## NOTES

- NOTE 1.** The address in addition to Post Office number (if any) should clearly define the location of the principal place of business in sufficient detail to enable any person readily to attend thereat.
- Note 2.** “Firm” means an unincorporated body of two or more individuals of one or more individuals and one or more corporation or two or more corporations who or which have entered into partnership for profit.
- Note 3.** A Seychellois National shall also state his Citizenship (if any).
- Note 4.** A former name does not include a change which occurred before the persons whose name has been changed attained the age of 18 years or a period of not less than 20 years has elapsed since the change occurred or a change of name by a woman in consequence of marriage. A married woman should however, include the forename and surname of her husband in addition to her own forename and surname.
- Note 5.** The additional particulars under head 10 are required to be furnished by a firm, individual or corporation carried on business wholly or mainly as a nominee or trustee of another person or corporation.
- Note 6.** The additional particulars under head 11 are required to be furnishes where any firm, individual or corporation carried on business as general agent for any foreign concern. provided that if such business carried on as three or more concerns it shall be sufficient to state that fact specifying the countries in which such foreign concerns carry on business.
- Note 7.** This statement is to be signed, in the case of an individual, by him and in the case of a corporation by a director or secretary and, in the case of partnership by all the individuals who are partners. In the case of a firm the statement may be signed by one individual who is a partner or by the director or secretary or a corporation which is a partner but only if verified by a sworn declaration
