- 2. Copy of State Registration Certificate of legal entity (with Registration of Director's appointment or if its company with foreign investment, with decision of director's appointment)
- 3. Fill the application form for company information
- 4. Completed CVs of 2 employees in charge of tourism /excluding director and deputy director/
- 5. Copy of diploma, certificate of tourism officers (with notarized copy)
- 6. Copy of labor contract with professional officials (with original copy)
- 7. Copy of a rent agreement or if it is own property, copy of a real estate certificate
- 8. Business plan of activity (at least 10 pages) including:
  - Company introduction
  - Market research
  - Planned business activity
  - Tour program, package price survey
- 9. Certificate fee 100 000 Tugriks (one hundred thousand). Copy of bank receipt

# International tour or outbound tour activity should prepare following additional documents:

- 1. Draft of the contract with tourists
- 2. The program of the Tour, package price survey
- 3. Copy of the contract with insurance companies
- 4. Copy of the contract with foreign partners
- 5. Financial guarantee of organization (Official letter and bank account description)

# List of required documents to extend the Certificate of Classification of tour organization

- 1. Official request letter (*Request should addressed to Mongolian Tourism Association*). Official letter should be on the official blank of the company
- 2. Copy of State Registration Certificate of legal entity (with Registration of Director's appointment or if its company with foreign investment, with decision of director's appointment)
- Fill the application form of brief introduction in table to extend the Certificate of Classification of tourism (*AX*-1 Application form)
- 1. Latest Certificate of classification of tourism organization /previous year's/
- 2. Extension fee 50 000 MNT (fifty thousand), or Copy of bank receipt
