THE TIMESHARE VACATIONS ACT

THE TIMESHARE VACATIONS (REGISTRATION, LICENSING, FEES AND FORMS) REGULATIONS, 2016

In exercise of the power conferred upon the Timeshare Registrar by section 24 of the Timeshare Vacations Act, and every other power hereunto enabling, the following Regulations are hereby made with the approval of the Minister:—

- 1. These Regulations may be cited as the Timeshare Vacations (Registration, Licensing, Fees and Forms) Regulations, 2016.
- 2.—(1) An application for a licence under section 3 of the Act (timeshare agent licence) shall be in accordance with Form 1 of the First Schedule.
- (2) A licence under section 3 of the Act shall be in accordance with Form 2 of the First Schedule.

- 3.—(1) For the purposes of section 3(5)(c) of the Act (licensing requirements for timeshare agents) a person is fit and proper if—
 - (a) in the case of an individual, the person—
 - (i) has attained the age of eighteen years or more;
 - (ii) is not an undischarged bankrupt; and
 - (iii) has not been convicted of any offence—
 - (A) involving fraud, dishonesty or moral turpitude; or
 - (B) under any law relating to real estate or tourism;
 - (iv) has successfully completed such courses of training in the field of—
 - (A) timeshare real estate; and
 - (B) real estate generally,

as may be required by the Timeshare Registrar for the purposes of this regulation;

- (v) has completed a period of attachment of at least one year in the office of a real estate dealer who has been approved by the Timeshare Registrar for the purposes of this regualtion; and
- (vi) passed such written and oral examinations as may be administered by the Timeshare Registrar for the purposes of this regulation;
- (b) in the case of a company—
 - no resolution has been passed, or order made by a court of competent jurisdiction, for the winding up of the company;
 - (ii) a receiver has not been appointed in respect thereof;
 - (iii) all of its directors meet the criteria specified in paragraph (a)(i), (ii) and (iii); and
 - (iv) the Timeshare Registrar is satisfied that the company has an appropriate number of staff qualified as mentioned in paragraph (a)(iv), (v) and (vi).
- (2) The Timeshare Registrar shall make available upon request a list of—
- (a) all courses of training required under paragraph (l)(a)(iv); and
- (b) all real estate dealers approved for the purposes of paragraph (l)(a)(v).
- 4.—(1) An application for registration of a timeshare plan under section 4 of the Act shall be in accordance with Form 3 of the First Schedule and, in the case of timeshare plans concerning timeshare accommodation under timeshare contracts in force immediately before

the date of the coming into operation of the Act, shall be accompanied by the following particulars in addition to the matters specified in the First Schedule to the Act—

- (a) proof of the executed timeshare contracts, in respect of the timeshare accommodation concerned, which predate the date of coming into operation of the Act; and
- (b) copies of all documents, issued to the purchasers, in the promotion of that timeshare accommodation.
- (2) A certificate of registration under section 4 of the Act shall be in accordance with Form 4A of the First Schedule.
- (3) For the purposes of section 4(6) of the Act, the endorsement of the Timeshare Registrar's approval of the transfer of a registration certificate shall be in accordance with Form 4B of the First Schedule.
- 5. An application to the Registrar of Titles under section 16 of the Act for the entry of a memorandum in the Register Book of Titles shall be in accordance with Form 5 of the First Schedule.
 - 6. For the purposes of section 17 of the Act-
 - the deed issued under section 16 of the Act shall be in accordance with Form 6A of the First Schedule;
 - (b) an assignment or transfer of a deed issued under section 16 of the Act shall be in accordance with Form 6B of the First Schedule; and
 - (c) a notice to the Timeshare Registrar as to the assignment or transfer of a deed issued under section 16 of the Act shall be in accordance with Form 6C of the First Schedule.
- 7. An application to the Timeshare Registrar under section 18(1)(a) of the Act for deregistration of timeshare accommodation shall be in accordance with Form 7 of the First Schedule.
- 8. An application to the Registrar of Titles for an entry under section 18(1)(b) of the Act (entry of memorandum of discharge in Register Book of Titles) shall be in accordance with Form 8 of the First Schedule.
- 9. For the purposes of section 24(3)(f), (h) and (j) of the Act, the fee payable in respect of each matter described in Column 1 of the Second Schedule shall be the fee set out in relation thereto in Column 2 of the Second Schedule.
